The Minutes of the Macon City Council Meeting July 12, 2022 – 6:30 P.M. 106 West Bourke Street Macon, Missouri 63552

Mayor Pro-Tem Tony Petre called the meeting to order with the following members in attendance: Tony Petre, Dick Schlanker, Ernie Lea, Caleb Dwiggins, Cheryl Blaise, Greg Wiggans, Chris Walk, and Jerold Carr.

Absent: None.

Approval of the Agenda:

Councilman Lea moved to approve the amended agenda moving item G: Appointment of a new Mayor and H: Swear in of new Mayor down to become the first items under New Business. The motion was seconded by Councilman Schlanker and approved by all voting in favor.

<u>Proclamation – Day of Tribute:</u>

Our region suffered a tragic incident on June 27th when an Amtrak passenger train derailed in Mendon Missouri resulting in loss of life. In gratitude to those who provided equipment and personal aid at the scene, Mayor Pro-Tem issued a proclamation declaring July 12, 2022 a Day of Tribute to honor the law enforcement officers, firefighters, first responders, and public servants that assisted in response to this tragedy.

Police Chief Adam Dawdy and Sergeant Andre Williams, two of the City of Macon employees that assisted in the rescue and recovery, were in attendance and received a Certificate of Appreciation.

Approval of minutes from previous meeting:

Appointment of Mayor:

City Attorney, Tim Bickhaus, advised the Council regarding the procedure to fill a vacancy of the Office of Mayor. Due to the resignation of Mayor Scott Bigham and pursuant to RSMo. §77.240, Council must nominate and approve, by majority of the eight members of council, a new mayor to serve the remainder of the vacated term of office.

Councilman Schlanker moved to nominate Councilman Anthony (Tony) E. Petre for Mayor. Councilman Dwiggins seconded the motion and Council unanimously approved Petre as Mayor by roll call vote as follows:

Holman had indicated that if nominated, he would accept the nomination. Petre thanked Holman for his willingness to serve again and for his past service to the community. Petre looks forward to working with the city departments to continue progress in a positive direction.

City Clerk Craigg administered the Oath of Office to the newly elected Mayor, Anthony (Tony) E. Petre.

Ordinance – OF THE CITY COUNCIL OF THE CITY OF MACON, MISSOURI AUTHORIZING EXECUTION OF THE NATURAL GAS COMMODITY PURCHASE CONTRACTS BETWEEN KINECT ENERGY AND MACON MUNICIPAL UTILITIES:

Considering the volatility in the natural gas market, the Board of Public Works believed it would be good to have pre-approved options available to take timely advantage of any price drop. At the June 20, 2022 Board of Public Works meeting the Board recommended that City Council authorize the Board of Public Works to execute two natural gas futures contracts with Kinect Energy for the November 2023-March 2024 winter season to procure a maximum of two 25% layers based on historical usage data at a cost not to exceed \$5 per dekatherm.

Councilman Dwiggins moved to place on the first reading, the ordinance authorizing execution of the natural gas commodity purchase contracts between Kinect Energy and Macon Municipal Utilities. The motion was seconded by Councilman Schlanker and approved by roll call as follows:

Power in Me Conference concert event request – Melanie Thrunau

Power in Me Conference requested approval to hold a concert, Nashville recording artist Leanna Crawford, in the Oak Street parking lot on September 10, 2022 from 3:30 PM to 10:00 PM. The first part of the event will be an obstacle course competition in Bevier followed by an evening music concert in Macon. The request includes closure of a portion of Vine Street between Oak and Rollins, closure of Oak Street parking lot and the connecting alley, and waiver of the noise ordinance for the duration of the event.

Councilman Dwiggins moved to approve the event request. The motion was seconded by Councilwoman Blaise and approved by all present voting in favor.

"Dash for Desto" event request – Destiny StrongER Foundation

The Destiny StrongER Foundation requested street closures for a 5K walk/run fundraiser event to drive awareness of the childhood cancer. The request includes closure of the event route from Rubey Park to the walking trail around Blees Lake and the event would be from 8:30 AM to 11:30 AM August 6, 2022. Volunteers would be available with signs and cones to close the intersections.

Councilman Lea moved to approve the event request. The motion was seconded by Councilman Dwiggins and approved by all present voting in favor.

Mayor's report:

Mayor Petre extended condolences to Stephanie Wilson over the loss of her brother Larry to cancer.

Petre sent well wishes for speedy recoveries for Councilman Wiggans' wife's' injury and Councilman Schlankers' wife's' illness.

Petre announced he had approved a waiver of the fireworks discharge ordinance by approving displays to be discharged on July 14 and July 23 by Lolli Bros Livestock Market Inc. who are celebrating 75-years in business this year.

Councilman Dwiggins appreciated that the Street Department crews were beginning work on the Benton/Hawthorne repair project.

Councilwoman Blaise expressed the same as Benton/Hawthorne are major collector streets.

Councilman Wiggans reminded everyone that the Lolli Bros Livestock Market Exotic Animal Sale is this week (July 13th-15th) and is expected to be the biggest one ever.
